WHEREAS, in terms of Section 14(1) of the NCTE Act, 1973 Mata Vashish Devi College of Education, VPO- Kangle, Mandi, Tehsil- Rewari, District- Rewari, Haryana, has submitted an application (Case No. APN-04700) to the Northern Regional Committee of NCTE for grant of recognition permission for starting B.Ed. Course of One year duration with a total intake of 100 (One Hundred only) students on 27<sup>th</sup> Aug 2007.

2. AND WHEREAS on 25.08.2007 in view of the application submitted by the institution, the Director, Higher Education, Haryana and the input received from the visiting team of the Council, Haryana, and the recommendation of the State Government, the Council has approved the institution/society fulfilling the requirements under the provisions of NCTE Act, 1973 and relevant regulations including the Norms and Standards for Secondary (B.Ed.) Education, and issued such an instruction to the institution/society, to start the programme and to financial resources available with it for the purpose of the programme and to selected staff etc. as per the details given in the attached copy.

3. NOW THEREFORE in pursuance of the above, in exercise of powers conferred by the NCTE Act, 1973, the Northern Regional Committee hereby grants recognition/permission to Mata Vashish Devi College of Education, VPO- Kangle, Mandi, Tehsil- Rewari, District- Rewari, Haryana, to start B.Ed. Course of Secondary level of One year duration with a total intake of 100 (One Hundred only) students from the academic year 2008-2009 in pursuance of Section 14(1) of NCTE Regulation, 2007 subject to the fulfilment of the following conditions:

- (i) The admission of students shall be done only after affiliation by the examining body before the commencement of the academic year and the completion of students shall be completed well before the cut-off date prescribed by the examining body for the academic year 2008-2009 taking into account the recognition will be deemed to be for the B.Ed. candidates up to 2008-09.
- (ii) Form of orders for the recognition/permission will operate for 2008-2009 and if the institution fails to start teaching days in the session year then it shall be cancelled by the University/ Affiliating Body.
- (iii) The institution shall submit a copy of the resolution/ recognition order, along with the prescribed fee, interest and accounts into joint accounts of the Council, Haryana and of the Northern Regional Committee.
- (iv) The institution shall comply with all the other norms and standards prescribed by the Council, Haryana and the NCTE Act, 1973.
- (v) The institution shall be liable for the liability after its complete affiliation from the examining body in pursuance of clause 14(1) of the NCTE Regulations, 2007.
